This permit expires one (1) year from date of permit approval, in the event of failure or neglect by the Applicant to perform and comply with the permit or the regulations set forth in the aforesaid Ordinances No. 1-1984 and 6-2022, Applicant acknowledges that the Borough may immediately revoke and annul the permit and order and direct the Applicant to remove any or all structures, equipment or property belonging to the Applicant and/or its contractors from the legal limits of the right-of-way and to restore the right-of-way to its former condition. In the event the Applicant violates and provision of the aforesaid Ordinances 1-1984 and 6-2022, the Borough shall have the right to enforce the provisions of the aforesaid Ordinances as provided for therein or as otherwise provided by law. In this respect, and without limiting the foregoing, in the event the Borough determines that such structures, equipment or property pose a threat to the public safety and the Applicant fails to remove the same after notice from the Borough to do so, any attorney of any court of record shall be authorized to appear for the Applicant, and to enter an amicable action of ejectment and confess judgement against the Applicant, and the prothonotary shall be authorized to issue forthwith a writ of possession with costs, without leave of court.
