ORDINANCE NO. 05-2023

**AN ORDINANCE OF THE BOROUGH OF TOPTON, BERKS COUNTY,
PENNSYLVANIA, INCREASING THE BASE RATES FOR MINIMUM
WATER AND SEWER USAGE AND RATES FOR EVERY ADDITIONAL
THOUSAND GALLONS OF WATER AND SEWER USAGE PER QUARTER
FOR COMMERCIAL AND INDUSTRIAL.**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Borough of Tipton, Berks County, Pennsylvania, in a duly constituted and advertised public meeting, as follows:

SECTION 1. Base Sewer Rates. The base rate sewer usage charges shall be as follows per Four Thousand (4,000) gallons per quarter:

Residential	\$93.60
Commercial	\$149.40
Industrial	\$149.40

SECTION 2. Charges for Additional Sewer Usage. The rate for every additional One Thousand (1,000) gallons for sewer usage over Four Thousand (4,000) gallons per quarter shall be as follows:

Residential	\$12.72
Commercial	\$20.88
Industrial	\$22.68

SECTION 3. Base Water Rates. The base rate water usage charge shall be as follows per Four Thousand (4,000) gallons per quarter:

Residential	\$52.20
Commercial	\$78.30
Industrial	\$78.30

SECTION 4. Charges for Additional Water Usage. The rate for every additional One Thousand (1,000) gallons for water usage over Four Thousand (4,000) gallons per quarter shall be as follows:

Residential	\$7.02
Commercial	\$10.53
Industrial	\$10.53

SECTION 5. Severability. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council of the Borough of Tipton that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.


SECTION 6. Repealer. All Ordinances or parts of Ordinances conflicting with the provisions of this Resolution are hereby repealed insofar as they are inconsistent with this Resolution.

SECTION 7. Effective Date. This Ordinance shall become effective on the earliest date permitted by law.


